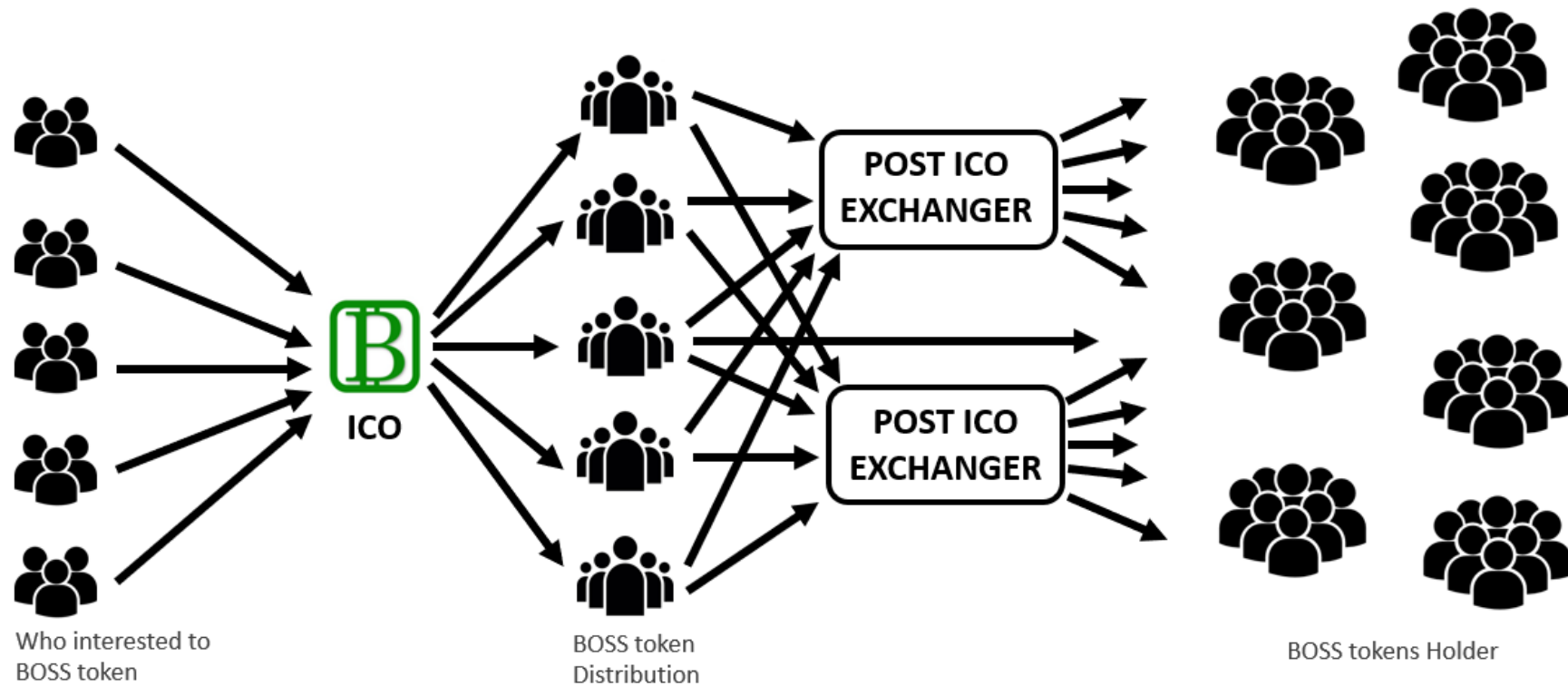

With a limited amount, being the ultimate choice and strong demand, BOSS Token will become an Asset that will always be of high value and interest.

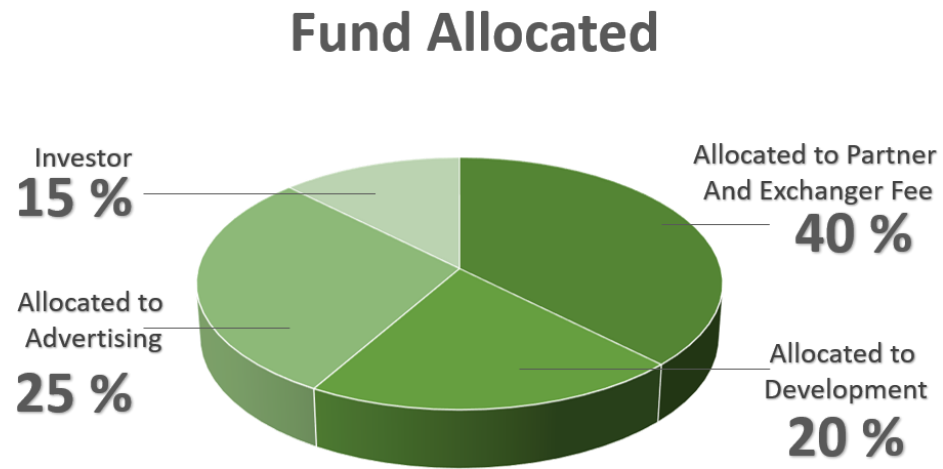
ICO

Sales are divided into three level which will start on 20th of September 2018at 00:00 UTC and will close on 30th November 2018 at 24:00 UTC.

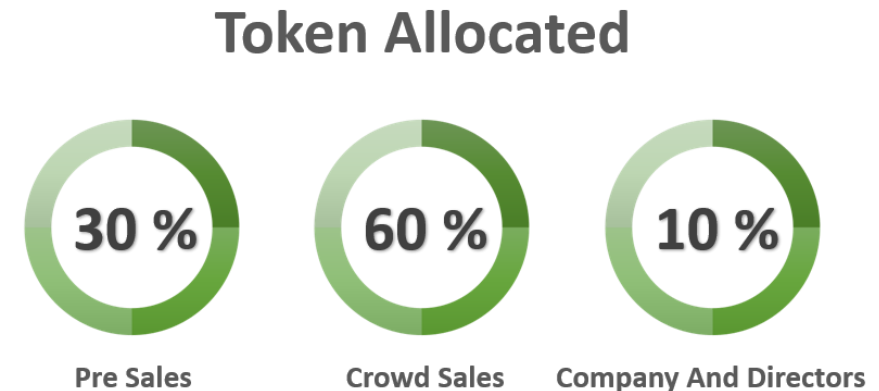
